Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Deed of Constitution (Unitary Form).

Recruitment and Appointment of Trustees

Members of the Kirk Session and the Congregational Board are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

Organisational Structure

The Kirk Session meets four times a year and is responsible for spiritual and temporal affairs within the church.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Achievements and Performance

Our Minister has continued the established pattern of services in AMS, with a weekly Sunday service in Ardgour at 10 a.m., and midday services alternating between Kiel and Strontian churches. Services are also conducted once a month at Kingairloch and Treslaig. He is supported by Ella Gill, Reader. On the fifth Sunday of the Month, there is a joint service followed by lunch in one of the three AMS churches. Communion Services took place quarterly in the churches.

For the linkage, on its 'peninsulachurches' website, Mr McCorkindale has posted a twice-monthly Sunday worship video on YouTube and livestreamed a church service on the alternate Sundays. He has posted evening prayers once a week and monthly live worship with Communion on zoom. He has a weekly podcast, and also keeps the Parishes' profile active on Facebook. His online work has been much appreciated both within the Parishes and beyond. From May, Donna Dugdale from Mull spent eight weeks in the linkage as part of her training for the Ministry.

Morvern had a very successful stall on 19th July, Gala Day, and held the Christmas Tree Festival again in December. The linkage had a tent at the Strontian Show on 9th August. Treslaig held a monthly Conversation group, a successful Harvest Festival dinner in October, and a Carol Service. The Peninsula Carol Service was held in Strontian Hall in December. There were five Remembrance services held throughout AMS on Sunday 9th November. In Ardgour, the "winter suppers" in the Hall ran for its third year, and funding for them was organized by Louise White, Elder. These suppers are now well-established and very successful. They bring the Ardgour community together.

On property, the Manse underwent a programme of repairs in the Spring. In Ardgour Church repairs are underway for storm damage to lead coping on the roof. The Meeting Room at Ardgour Church was re-decorated by James Campbell, Property Convenor. A Stewardship team was appointed for Kiel Church where the south gable of the church needs repointing, and the Bell Tower needs repair.

Following a joint Kirk Session meeting of AMS & AA, a steering group was set up to develop a Ministry and Mission Plan for the charge. They identified five areas of development, (1) Worship Leader Training, (2) Technology, (3) Youth Ministry, (4) Music Ministry, and (5) Finance. Sub-working groups for all these areas have formed, and work is progressing. A conclusion from this was that A&A will fund an Associate Minister post, employing Rev Duncan MacPherson, Kilchoan. When he assists with services within AMS then they will pay pulpit supply to A&A.

Finally, Strontian Church was sold to the Strontian Community Company (Dualchas) in July for £50,000. In agreement with the Community Company, the building will be available for Church Services.

Financial Review

The third annual accounts of the united Ardgour, Morvern and Strontian Parish. It is based on the funds available within our two initial bank accounts (Current Account and Fabric Account), alongside funds held centrally with the Church of Scotland. The principal source of income comes from offerings received at our regular services across five different locations, plus regular donations from congregational members who continue to support the church despite being unable to attend. The Giving to Grow allocation of £14,051 has been paid in full. Half way through the year we closed our Fabric Account with Bank of Scotland due to extra charges, and merged it all into our new Charity Account.

We spent £6,758.70 on the Ardgour Winter Suppers, which was funded through the £6,100 'Highland Communities Mental Health & Wellbeing Fund for Adults – Small Grants' received in 2024, £175.29 from the Ardgour Community Council carried over from 2024, and £483.41 in donations. The Ardgour Winter Suppers in 2026 will no longer be run by the Church, and instead will be organised by the Ardgour Glensanda Development Trust.

We spent slightly less overall this year (£44,731.69) compared to 2024 (£44,920.14). When looked at actual costs, it was an even bigger gap (2025 - £36,819.39 and 2024 - £38,987.70). This is primarily due to spending £2,895.37 less on Church Electricity, £2,938.40 less on Manse Repairs & Maintenance, and £752.71 less on Church Fabric Repairs & Maintenance. Over half of our Church Fabric costs were paid through the Consolidated Fabric Fund (Revenue) for grass cutting. Interestingly, in 2025 we did spend £5,521.92 more on general ministry costs (e.g. G2G, Pulpit Supply, Travel Expenses etc.). Some of these costs will have been part-reclaimed through shared costs with Acharacle & Ardnamurchan (total received £4,936.47).

We collected £1,337.60 for third parties this year, and have given £1,153.60 of that in this years accounts. The amount collected included the £171.50 that was collected last year for Life & Work, which ceased publication this year. Therefore we received a refund of £52.50 from CofS for the Life & Work's that they didn't publish, which needs passed back to the members of the congregation who paid for it. There is also an addition £100 collected for Shelter in December, that will be paid to them in the 2026 accounts. Finally, we received a Legacy of £500 from the Estate of Helen Middleton.

Our donation income increased slightly this year (2025 - £25,599.33 and 2024 - £24,013.90) but this was mainly reflected in the additional £1,844.77 received in Gift Aid reclaim and an additional £802.38 from Gift Aid specific donations. We had a reduction in giving from both WFO & Ordinary Offerings. We also had significantly less income from Weddings & Funerals (2025 - £270 and 2024 - £1,718.24).

Overall this year it appears that we spent £4,530.74 more than we received. But as we didn't receive any new funding for Winter Suppers this year, we only show their costs. Removing that from the total figures shows we received £2,227.96 more than we spent. This figure doesn't reflect the outstanding amounts owed to third parties, or the remaining Winter Supper donations. Whilst this is positive, we have spent little on maintenance and repairs, and have not seen a significant rise in giving – both of which should be greater consideration for the future.

Statement of Trustees' Responsibilities

Independent Examiner's Report to the Trustees of Ardgour, Morvern and Strontian Parish Church

I report on the accounts of the charity for the year ended 31st December 2025 which are set out on pages 9 to 14.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

An examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.
